2. 參賽資格 Eligibility (1) 歡迎有興趣的機構以機構/政府部門的名義參加。

Interested parties are welcome to take part in the competition in the name of their organisations or government departments.

(2) 參賽者必須年滿 15 歲,並須在有關比賽截止遞交參賽者資料的日期前,已連續為參賽機構工作最少 4 星期,每星期工作最少 18 小時,以及在整段比賽期間一直受僱於該機構。

A participant shall be aged 15 or above who has been working continuously for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadline for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

(3) 參賽者在整個運動會期間只可代表 1 間機構參賽。

A participant shall represent only 1 organisation throughout the Games.

(4) 大會保留拒絕任何參賽者參賽的權利。

The Organiser reserves the right to forbid any participant from taking part in the competition.

5. 費用 : 每間機構 1,000 元正 Fees \$1,000 / each organisation

6. 賽制 Format

- (1) 截止報名後,如有任何組別/項目少於三隊報名,該組別/項目將會取消。 If the number of teams enrolled in any group/event is less than three after the enrolment deadline, the group/event will be cancelled.
 - (2) 截止報名後,如籃球比賽的總報名隊數不足總名額的一半,大會有權取消整個比賽。

If the total number of teams in the Basketball Competition is less than half of the overall quota after the enrolment deadline, the Organiser has the right to cancel the whole competition.

(3) 初賽採取分組單循環制,以3隊或4隊為一小組(視乎報名情況)。每小組首名出線,出線隊伍再以單淘汰制進行比賽。

(大會有權因應報名情況而更改每項賽事的賽制。)

A single round robin system on group basis will be adopted in the preliminary round. Each sub-group will consist of 3 or 4 teams (depending on actual enrolment situation). A single knockout system will be adopted for matches among each sub-group's champion .

(The Organiser reserves the right to change the format of competition for each event in consideration of the enrolment situation.)

(4) 初賽分組編排由大會抽籤決定。

Grouping for matches in the preliminary round will be decided through fixture draw by the Organiser.

(5) 全場比賽時間為 40 分鐘, 分 4 節, 每節 10 分鐘。第一與第二節比賽和第三 與第四節比賽之間的休息時間為 1 分鐘,半場(第二與第三節比賽之間)休息時間為 5 分鐘。比賽計時鐘將按「中國香港籃球總會」的規定,於休息時間暫停。 The duration of each match will be 40 minutes, consisting of 4 periods of 10 minutes each. There will be intervals of 1 minute between the first and second periods, and between the third and fourth periods. The half-time interval (i.e. between the second and third periods) is 5 minutes. The game clock will be stopped at intervals according to the Rules and Regulations of the Basketball Association of Hong Kong, China.

(6) 如在第四節比賽時間結束時得分相同,加時 5 分鐘;再和,則每隊指派 5 名 參賽者互射罰球,採用「即時死亡」制決定勝負。

If the score is tied at the end of playing time for the fourth period, there will be an extra period of 5 minutes. If the match still ends in a draw after the extra time, 5 participants of each team should be assigned to shoot a free throw and the "sudden death" rule will be adopted.

- 7. 計分法 Point Scoring System
- (1) 在單循環制賽事中,每場勝方得 2 分,負方得 1 分,而棄權得 0 分。棄權隊 伍作 0:20 落敗論。

In matches adopting the single round robin system, the winner gains 2 points and the loser gains 1 point. The withdrawer gains no points and will be taken as being defeated in the match by 0:20.

(2) 在單循環制賽事中,如 2 隊積分相同,則以該 2 隊對賽成績勝者為勝;若同分者超過 2 隊,則以有關隊伍的相關比賽得失球差額以決定勝負;若未分出勝負,則以全部比賽總得失球差額決定名次。如仍然相同,則以抽籤決定名次。

In matches adopting the single round robin system, if 2 teams score the same points, the winner will be the win side of the match between the 2 teams. If more than 2 teams score equal points, the winner will be determined by the goal differences of the respective matches played by the teams involved. If the tie persists, the ranking will be determined by the goal differences of all matches. If the scores are still equal, ranking will be decided by balloting.

8. 獎勵 Awards : 各組別的每個項目均設冠、亞及季軍(各得獎隊伍必須參與最少1場賽事方可獲得 獎項)。

Prizes will be awarded to the Champion, 1st runner-up and 2nd runner-up of each event in the respective groups (the winning team must have played in at least 1 match in order to be awarded any prize).

9. 賽規 Rules (1)雙方領隊、教練或隊長須填妥出場表並於球賽開始前 15 分鐘交到報到處。各 參賽者亦須親自攜同附有相片的有效身份證明文件正本(例如:香港永久性 居民身份證、香港居民身份證)到報到處報到。參賽者如無法出示證件或被 發現身份不符,一律不准出賽,以及不得換人補上。各參賽隊伍必須依照大 會編定的時間出場比賽。於裁判召集出場 5 分鐘後,仍未能出場作賽或當比 賽進行時參賽者不足 2 人者,將作自動棄權論,大會將判對賽隊伍以 20:0 勝 出。

Team leaders/coaches/captains of both teams shall duly complete and submit the lists of participants to the registration counter 15 minutes before the commencement of the competition. All participants shall report to the registration counter in person with the originals of their valid photo-bearing identity documents (e.g. Hong Kong Permanent Identity Card, Hong Kong Identity Card). Any participant who fails to produce his/her valid identity document or whose identity is unmatched will not be allowed to participate in the competition and no replacement of athletes will be allowed. All participating teams shall turn up at the scheduled time for the match. Any team that fails to turn up within 5 minutes after the roll call made by the referee or dispatches less than 2 participants during the match will be regarded as having withdrawn from the match, and the opponent will be judged as the winner by the Organiser at a score of 20:0.

- (2) 如有參賽隊伍在分組單循環制的任何 1 場賽事棄權,棄權隊伍會在該賽事中被判 0:20 落敗,但仍可繼續參與其他賽事。而在採單淘汰制的賽事中,棄權隊伍則會被取消資格,不能繼續參與餘下賽事,其所得名次及積分會被全數取消,惟以下情況除外:
 - 進入4強賽至決賽的參賽隊伍,如有球員因傷病或公事未能參賽,導致該隊伍人數不足無法出賽,須提供由註冊醫生或該公司簽署的相關證明文件,方可保留參賽隊伍在最後賽事的名次和積分。該隊領隊/教練/聯絡人必須於該參賽隊伍開賽前或缺席賽事後2個工作天內向大會提供有關證明文件。逾時提交者作棄權論。

If a team withdraws from a match under the single round robin system on group basis, it will be judged as the loser at a score of 0:20 but they can still participate in other matches. For matches where a single knockout system is adopted, the withdrawn teams will be disqualified from playing in the remaining matches, and all the positions obtained and points scored by the team will be cancelled except in the following circumstance.

- If a team fails to turn up in full in semi-finals and finals due to absence of player(s) on the grounds of injury/illness or work engagement, the position the team attained and the points it scored in the last match can be retained if the absent player(s) can produce relevant supporting documents issued by registered medical practitioners or the organisation. The team leader/coach/contact person is required to provide the relevant supporting documents before the start of the match or within 2 working days after the match from which the participating teams were absent. Late submission will be regarded as withdrawal from the match.
- (3) 參賽者/參賽隊伍如違反規則或有不良行為而影響賽事,大會有權取消其個人/隊伍的參賽資格,所得成績亦會作廢。

The Organiser has the right to disqualify any participant/team that violates the regulations or commits misconduct which may affect the competition, and the results he/she/the team has achieved will be cancelled.

- (4) 大會有權取消嚴重犯規者的比賽資格。
 - The Organiser has the right to disqualify a participant who has seriously breached the regulations of the competition.
- (5) 除本章程明文規定外,其餘均依照中國香港籃球總會的現行比賽規則辦理。 Unless explicitly stated in this prospectus, all rules and regulations will follow those presently adopted by the Basketball Association of Hong Kong, China.
- (1) 所有賽事採用由大會供應的籃球作賽。

Basketballs provided by the Organiser shall be used in all matches.

- (2) 參賽者必須穿着不脫色的運動鞋作賽。
 - Participants should wear non-marking sports shoes for competition.
- (3) 各參賽隊伍必須預備 2 套顏色不同的比賽球衣參賽,球衣號碼必須根據籃球 比賽規例為 00 至 99 號。在比賽時間表上的「主隊」參賽隊伍應穿着淺色球 衣,「客隊」則應穿着深色球衣。如遇 2 隊參賽隊伍球衣顏色相同或相若,則 違反顏色規定的參賽隊伍須更換其球衣,或穿着大會供應的號碼背心。

Each team shall prepare 2 sets of numbered jerseys in different colours for competition and the numbers indicated on the jerseys should be from 00 to 99 in accordance with the basketball competition rules. The "home team" on the competition schedule should wear light-coloured jerseys, and the "away team" should wear dark-coloured jerseys. If 2 teams wear jerseys of the same or similar colour(s), the team who has violated the colour rules on jerseys should change their jerseys, or wear the numbered vests provided by the Organiser.

Organisations which have successfully enrolled in the competition should make crossed cheques (post-dated cheque is not accepted) payable to "The Government of the Hong Kong Special Administrative Region" and submit the cheques in person or by post to Major Events Section of the Leisure and Cultural Services Department (Address: 2/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories) during office hours on or before 13 February 2025 (Thursday). "Particulars of Participants", "Declaration by Participants Aged 18 or above" and/or "Declaration by Participants Aged below 18" should be returned by post, in person or by fax (Fax No.: 2634 0786) to the section according to the deadlines below:

- Submission of "Declaration by Participants Aged 18 or above" and/or "Declaration by Participants Aged below 18" on or before 12 June 2025 (Thursday)
- (2) 每隊須填報 1 名年滿 18 歲的領隊/教練,以及最多 20 名參賽者,惟每場比賽最多只有 12 名隊員具比賽資格。

Each team should submit 1 team leader/coach aged 18 or above and 20 participants at maximum, but no more than 12 team members are entitled to play in each match.

(3) 於 2025 年 6 月 12 日(星期四)後,所有參賽隊伍均不得更改參賽者名單。 如有參賽者受傷或辭職,而有關機構欲更改參賽者名單,須盡快於辦公時間 內向大會提出書面申請,並提交受傷參賽者的醫生證明書或有關機構認可的 證明,大會會因應個別情況作出考慮。

Any change of the list of participants is not allowed after 12 June 2025 (Thursday). In case of injury or resignation of any participant, application for change of the list will only be considered on a case-by-case basis provided that the application is made in a written form within the office hours to the Organiser as soon as possible and attached with the medical certificate(s) of the injured person(s) or approved document issued by the organisation.

(4) 如發現機構呈交的參賽者資料與參賽者身份證上的資料不符,大會有權取消 其參賽資格。

The Organiser reserves the right to disqualify a participant if there is any discrepancy between personal information shown on his/her identity document and that submitted by his/her organisation.

12.領隊會議及對賽抽籤
Team Leaders' Meeting and Fixture Draw

領隊會議將於 2025 年 6 月 12 日(星期四)晚上 7 時,在新界沙田排頭街 1 至 3 號康樂及文化事務署總部 1 樓視聽室舉行,屆時將進行對賽抽籤,歡迎參賽機構派代表出席。參賽者名單必須於領隊會議舉行當日或之前落實,大會於對賽抽籤後將不接納任何更改參賽者名單的申請。沒有派代表出席的機構,對抽籤結果不得異議。A team leaders' meeting and fixture draw will be held at 7 pm on 12 June 2025 (Thursday) at the Audio-visual Room, 1/F, Leisure and Cultural Services Headquarters, 1-3 Pai Tau Street, Sha Tin, New Territories. Participating organisations are welcome to send representatives to attend. The list of participants must be confirmed on or before the date of the meeting. No application for change of the list will be accepted after the fixture draw. Those organisations failing to send representatives shall raise no objections to the results of the draw.

13.裁判

Referee

: 比賽的執法工作由合資格裁判擔任,各參賽者須服從裁判的判決。

Judges will be served by qualified referees. All participants should abide by their decisions.

14. 上訴

Appeal

15.惡劣天氣安排 Inclement Weather Arrangement : 大會不設上訴,所有賽果以裁判最後判決為準。

No appeal will be accepted. The referees' decision on the competition results shall be final.

(1) 如在比賽當日,第一輪賽事報到時間前2小時,香港天文台發出8號熱帶氣旋 警告信號預警,或8號或以上熱帶氣旋警告信號或黑色暴雨警告信號仍然生 效,該日賽事即告取消。大會稍後會通知各參賽者相應安排。

If the Pre-No. 8 Special Announcement has been issued by the Hong Kong Observatory 2 hours before the reporting time for the first round of matches on the competition day, or the Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is still in force, the competition on that day will be cancelled. The Organiser will notify the participants of the corresponding arrangements separately in due course.

(2) 如環境保護署(環保署)於比賽當日公布的空氣質素健康指數為7級或以上,有關比賽的安排如下:

When the "Air Quality Health Index (AQHI) of 7 or above" has been issued by the Environmental Protection Department (EPD) on the competition day, the arrangement of the competition as follows:

Competition will be held as scheduled. The EPD advises those with existing heart or respiratory illnesses (such as coronary heart disease and other cardiovascular diseases, asthma and chronic obstructive airways diseases including chronic bronchitis and emphysema), children and the elderly to **reduce** outdoor physical exertion, and to **reduce** the time of their stay outdoors, especially in areas with heavy traffic. Participants with existing heart or respiratory illnesses should also seek advice from a medical doctor before participating in sports activities and take more breaks during physical activities. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

The general public is advised to **reduce to the minimum** outdoor physical exertion, and to **reduce to the minimum** the time of their stay outdoors, especially in areas with heavy traffic. As the health effects on individuals may vary, participants should seek advice from a medical doctor if they are in doubt or feel uncomfortable.

16.改期 Changing the Date of Competition

(1) 大會有權因應特殊情況改期作賽或另作安排。如在比賽中出現突發情況,得由當場裁判或大會全權決定是否繼續舉行比賽,參賽者不得異議。

The Organiser reserves the right to change the date of a competition or make any alternative arrangements under special circumstances. Should anything unforeseeable happen during the competition, the referee on the spot or the Organiser has full discretion about whether the competition should continue or not and participants shall raise no objection.

(2) 比賽期間,參賽隊伍如已進行其中 1 項比賽,即使其後因天氣惡劣或其他原因而不能參加餘下賽事,已繳交的報名費概不退還。

For a team who has already taken part in one of the events during the competition period, if the team cannot participate in the remaining competitions due to inclement weather or any other reasons, there shall be no refund of the entry fee already paid.

(3) 大會不接受參賽隊伍的改期申請。

No application for changing the date of any competition from a participating team is accepted.

17.附則 Remarks (1) 「僱員」的定義為該僱員須在比賽截止遞交參賽者資料日期前,已連續為參 賽機構工作最少 4 星期,每星期工作最少 18 小時,而且在整段比賽期間一直 受僱於該機構。

The definition of "employee" — An employee who has been working continuously for the participating organisation for at least 4 weeks and at least 18 hours per week before the deadline for submission of participants' particulars for the competition, and is employed by the same organisation throughout the competition period.

(2) 參賽者必須任職於有關機構為「僱員」及年滿 15 歲。

A participant shall be an employee of the participating organisation and aged 15 or above.

(3) 為確保參賽者為參賽機構的僱員,大會有權要求參賽機構於5個工作天內出示 有效的「僱傭合約」及強制性公積金供款紀錄,以證明參賽者為該機構的現職 僱員。參賽機構須於報名前得到參賽者同意提供「僱傭合約」及強制性公積金 供款紀錄予大會核查其僱員身份。如未能提供有關文件,該機構的參賽資格會 被取消,已繳交的報名費概不退還。

To ensure all the participants are employees of the participating organisations, the Organiser reserves the right to request the participating organisations to produce valid employment contracts and contribution records of Mandatory Provident Fund (MPF) within 5 working days to prove that the participants are existing employees of the organisation. Participating organisations are required to obtain the participants' consent to provide employment contracts and contribution records of MPF to the Organiser for verification of their employee status before registration. An organisation failing to produce such documents will be disqualified from the competition and there shall be no refund of the entry fees already paid.

(4) 参賽者必須遵守比賽場地內的各項守則及大會的各項宣布。

Participants shall comply with all the rules and regulations prescribed by the competition venue and the announcements of the Organiser.

- (5) 大會保留權利拒絕讓違反以上規則的機構參加日後的工商機構運動會。 The Organiser reserves the right to refuse participation of any organisation in breach of the above rules in the Corporate Games in future.
- (6) 大會有權向外公布比賽成績。

The Organiser has the right to release the results of the competition to the public.
