

## 2024 Hong Kong Youth Music Interflows – Symphonic Band Interflow Regulations

1. The Symphonic Band Interflow is organised as follows:  
 Date: 3 to 6 December (Tue - Fri)  
 Subject to the number of participating schools, date and time of the Interflow classes will be confirmed and announced from 26 September at the Music Office website: [www.lcsd.gov.hk/musicoffice](http://www.lcsd.gov.hk/musicoffice)  
 Venue: Arena, Queen Elizabeth Stadium
2. The Interflow is divided into 6 classes, accepting entries from local primary schools and secondary schools. The size of each band should be between 20 and 80 players (exclusive of conductor). Details are as follows:

Class	Time Limit	Level	Piece(s) to be performed
Primary School Junior Class	8 minutes	<b>Below</b> Level 2 ( <i>exclusive of Level 2</i> )	<i>See Remarks below</i>
Primary School Intermediate Class	10 minutes	<b>Below</b> Level 3 ( <i>exclusive of Level 3</i> )	
Primary School Senior Class	12 minutes	Level 3 <b>or above</b>	
Secondary School Junior Class	12 minutes	<b>Below</b> Level 3 ( <i>exclusive of Level 3</i> )	
Secondary School Intermediate Class	14 minutes	<b>Below</b> Level 4 ( <i>exclusive of Level 4</i> )	
Secondary School Senior Class	20 minutes	Level 4 <b>or above</b>	

**Remarks:**

- i. There is no limitation on the number of pieces to be performed by each participating school;
  - ii. Each piece must be a PUBLISHED work;
  - iii. Each piece must conform to the stipulated level for the class enrolled;
  - iv. **Participating schools are responsible to ensure that their performing pieces meet the stipulated requirement of the enrolled class** and to provide the page of music score indicating the level of the work, or declaration of publisher/ composer/ arranger. (Please check with the publisher/ composer/ arranger if there is no indication on the music score.) **If the participating schools fail to provide eligible proof of the level of the work(s), the Music Office reserves the right to disqualify the schools;**
  - v. For the piece(s) with more than one movement, the selected movement(s) to be performed should be indicated on the application form, otherwise a performance of the **whole work** will be deemed.
3. Each school may only enroll in one of the above classes and should clearly indicate the choice of class for participation on the application form. **Request for change of class will not be accepted after the application deadline (12 September).**
  4. Members of the participating band (with the exception of the conductor) must currently be bona fide registered students of the same school. The Music Office will not accept entries for any joint-school performing bands. Separate entries are required for schools with the same name but with individual registration for their AM and PM sections, schools with primary and secondary sections, or schools with branches in different districts.
  5. Calculation of performing time starts from the first note played by the participating band until the end of the whole performance (inclusive of the break between pieces/ movements). For the performance exceeding the time limit, 3 marks per minute (less than one minute is also counted as one minute) will be deducted from the total score of the participating band.
  6. The **top two Gold Award participating bands** of each class will be invited to compete for the “Tom Lee Cup” of the Primary School Classes and the Secondary School Classes at the **Symphonic Band Extravaganza** listed below:  
 Date: 7 December (Sat)  
 Time: 2pm  
 Venue: Arena, Queen Elizabeth Stadium  
 Remarks:
    - i. Perform **one** of the performing pieces
    - ii. Change or substitution of band members is not permitted
  7. Dress rehearsal will not be arranged. Order of performance will be determined by ballot on 20 September and posted on the above Music Office website on 26 September. Any request for change of the performance order, date and/ or time will not be accepted. The participating band that does not perform in the assigned order, will receive comments only, neither awards nor marks will be given.
  8. The Music Office will provide music stands, conductor stand, upright piano, timpani (one set of four) and bass drum. Participating bands must bring along their own mallets and other musical instruments needed for the performance. Participating bands have to arrange their own staff/ players to manage its stage setting before the performance, and move the musical instruments before and after the performance. (Note: No orchestral risers will be provided.)

9. Gold, Silver, Bronze and Merit Awards will be granted to the bands for their achievements:

10. The number of awards to be presented will be decided by the adjudication panel whose decision on the results and awards shall be final. The adjudication panel also reserves the right to withhold any award(s) if the performance of participating band is not up to the standard. The trophies of “Tom Lee Cup” of the Primary School Classes and the Secondary School Classes will be kept by respective awardees for one year and returned in the following year. The trophy will be kept permanently by a band for being awarded in three consecutive years. Results will be announced immediately after each class. Participating bands will be informed of the collection arrangements of prizes and mark sheets at a designated music centre of the Music Office on the performance day. All prizes are sponsored by Tom Lee Music.
11. Deadline of Application: **12 September (Thursday) 5pm**  
Application form should be duly completed and emailed to [hkymi-app@lcsd.gov.hk](mailto:hkymi-app@lcsd.gov.hk) on or before the above deadline.
- The Music Office will send the **acknowledgement of application**, assigned with an **application number**, by email within two working days upon receipt of the application. If any school does not receive it by **17 September**, please check with the Music Office by 3pm on this day to ensure its application is successfully submitted.
12. Any change of submitted information (exclusive of class) as provided on the application form must be **countersigned by the school principal** and emailed to [hkymi-band@lcsd.gov.hk](mailto:hkymi-band@lcsd.gov.hk) **on or before 4 October**. If the changes are related to **the performing piece(s)**, the Music Office will issue an acknowledgement email within two working days upon receipt. If the school has not received the acknowledgement email by then, please check with the Music Office by phone immediately.
- Participating bands which **change performing piece(s)/ movement(s) after 4 October** will receive comments only, neither awards nor marks will be given.
13. The following information (if not yet submitted with the application form) should be sent to [hkymi-band@lcsd.gov.hk](mailto:hkymi-band@lcsd.gov.hk) **on or before 4 October**:
- Members’ list (validated with school chop and signature of school principal)
  - Proof of the level of work(s)
  - Stage plan
14. On the performance day, each participating band must present to the adjudication panel with a total of **three** original/ authorised copies of the conductor’s score of the performing piece(s) for adjudicators’ reference before the start of that Interflow session. Otherwise, its participation in the Interflow will be disqualified. Any alterations of music should be clearly marked on the scores. Person-in-charge of the participating band should particularly observe Clause 15 below and ensure the scores provided are original or authorised copies. Participating bands should also claim the scores back from staff at the adjudication panel after the presentation ceremony/ respective Interflow session. The Music Office will not be held liable for any loss of unclaimed items.
15. Participating bands must comply with the copyright law of Hong Kong in using music scores and are liable for infringement of copyrights. Otherwise, the participating bands shall bear legal responsibility in accordance with the law.
16. The Music Office shall have the absolute discretion to use any photograph, video or any other record of the Interflow for any lawful purposes including but not limited to archival, advertisement and event promotion.
17. Participating bands should fully observe and abide by all the above regulations, all rules of the performing venues and the laws of Hong Kong. The Music Office reserves the right to disqualify a participating band or terminate its participation in the Interflow if the band violates the aforementioned regulations. Participating bands in question may receive comments only, neither awards nor marks will be given. Participating bands/ members shall bear legal responsibility for their acts of breach.
18. Should there be disputes, the Music Office reserves the right to the final decision.
